"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, as part of Lots 26 and and 27 on a Plat of Gower Estates, Section C-1, by R. K. Campbell, surveyor, dated July 27, 1963 and recorded in Plat Book YY at Page 112 in the RMC Office for Greenville County and being more particularly described as follows:

BEGINNING at an iron pin on Ponderosa Rd, said pin being 11 feet N. 30-51 E. from the joint front corner of Lots 27 and 28; thence from said beginning point along a new line through Lot 27 N. 53-39 W. 181.4 feet to an iron pin; thence N. 24-07 E. 125 feet to an iron pin; thence S. 68-50 E. along a new line through Lot 26 188.9 feet to the Ponderosa Rd; thence S. 24-11 W. 21 feet to an iron pin; thence S. 27-19 W. 10 feet along the curve of the Ponderosa Rd.; thence continuing with the curve of said road S. 28-13 W. 109.9 feet to an iron pin; thence S. 30-51 W. 31.1 feet to the beginning point.
