"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, 2 miles Northwest of Town of Greer, on the eastern side of Dogwood Avenue, being known and designated as Lot 2 on a plat of W. Dennis Smith, prepared by H.S. Brockman, dated September 14, 1957 and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book NN at page 168 and having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the Eastern side of Dogwood Avenue at the joint front corner of Lots No. 1 and 2 and running thence with the line of Lot No. 1, N. 88-17 E. 192.8 feet to an iron pin; thence with the rear line of Lot No. 9 N. 0-10 W. 102.5 feet to an iron pin at the joint rear corner of Lots No. 2 and 3; thence with the line of Lot No. 3 S. 89-29 W. 192.8 feet to an iron pin on the Eastern side of Dogwood Avenue; thence with the Eastern side of Dogwood Avenue S. 0-10 E. 95 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any lent or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner, it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
