MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Karl K. Siverling & Linda H. Siverling == (hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of Twenty-seven Thou-

sand Four Hundred Fifty and No/100 ----- (\$ 27,450,00 ---)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of-this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of One Hundred Ninety-

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor in the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of

ALL that piece, parcel or lot of land situate, lying and being on the northwestern side of Tussock Road near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 225 of a subdivision known as Del Norte Estates, Section 2, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book 4N at Pages 12 and 13 and according to said plat has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Tussock Road at the joint front corner of Lots Nos. 225 and 226 and running thence with the joint line of said lots N. 46-30 W., 130 feet to an iron pin; running thence N. 43-30 E., 95 feet to an iron pin at the joint rear corner of Lots Nos. 225 and 224; running thence with the joint line of said lots S. 46-30 E., 130 feet to an iron pin on the northwestern side of Tussock Road; running thence with the northwestern side of said road, S. 43-30 W., 95 feet to an iron pin, point of beginning.
