NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, about

six (6) miles northwest of the City of Greer on the southeast side of the (now known as Waters Road)
Old Darby Mill Road, containing 2 acres, more or less, and being shown on a survey entitled "Property of James D. Lister", dated May 27, 1972, by T. H. Walker, Jr., Surveyor, to be recorded, and having according to said plat the following metes and bounds, to-wit:

BEGINNING on a nail and cap in center of Old Darby Mill Road (iron pin back at 25 feet), said beginning point being 1,796 feet from State Highway No. 290 and running thence S. 56-50 E. 306 feet to an iron pin; thence S. 51-54 W. 271 feet to an iron pin; thence N. 73-15 W. 300 feet to a nail and cap in Old Darby Mill Road (iron pin back at 30 feet); thence along and with Old Darby Mill Road N. 44-30 E. 350 feet to the point of beginning.

Together with all and singular the rights, members, hereditainents, and appurtenances to the same belonging or in any way incident or appertaining; and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
