C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina. Country of Greenville, C'Neal Township, containing 5.75 acres on W. side of Thompson Road being shown on plat of Survey prepared by Terry T. Dill, Surveyor, Dated 7-22-71, as follows:
