MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

William Herbert Sugg III and Wife, Patricia E. Sugg

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgaged) in the full and just sum of

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate (inder certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of

One Hundred Sixty and 82/100 (a 160.82) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, it not sooner paid, to be due and payable 30 years after date; and June, 2002.

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any infiltre to comply with and abide by any fly-Laws of the Charter of the Mortgage, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may bereafter become indebted to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3,00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby seknowledged, hus granted, bargained, soid, and released, and by these presents does grant, largain, self and released, and the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, shown and designated as Lot 13, Section One, Pelham Woods Subdivision, plat of which is recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 4-F, Page 33, and having according to said plat the following metes and bounds, to-witi

BEGINNING at an iron pin on the northwesterly side of Coach Hill Drive at the joint front corner of Lot 12 and 13 and running thence along the common line of said lots N. 56-22 W. 150 feet to an iron pin; thence S. 61-06 W. 96.92 feet to an iron pin on Maplewood Drive; thence along Maplewood Drive S. 43-14 E. 105.44 feet to an iron pin; thence continuing along Maplewood Drive S. 56-25 E. 67.10 feet to an iron pin at the intersection of Maplewood Drive and Coach Hill Drive; thence with said streets, N. 78-44 E. 35.26 feet to an iron pin on Coach Hill Drive; thence along Coach Hill Drive N. 33-35 E. 85 feet to the point of beginning.
