(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Ten Thousand and no/100ths** -----

DOLLARS (\$ 10,000.00 ) with interest thereon from date at the rate of **eight (8%)** per annum per annum, said principal and interest to be paid as therein stated, and

WHEREAS the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW KNOW ALL MEN That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and to the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee its successors and assigns.

That piece, parcel, or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina County of **Greenville**, in the **Town of Travelers Rest**, known as **Lot 40 on plat of Sunny Acres**, recorded in the RMC Office for Greenville County in Plat Book BB at page 168, and having according to said plat, the following metes and bounds, to-wit:

**BEGINNING** at an iron pin on the northern side of Cox Drive at the corner of Lot 41 and running thence N 33 W 149.1 feet to an iron pin; thence N 57 E 75 feet to an iron pin; thence S 33 E 151.7 feet to an iron pin on the northern side of Cox Drive; thence with said Drive S 56-05 W 75 feet to the point of beginning, and being one of the lots conveyed to the Mortgagor in Deed Book 939 at page 104, and subject to restrictions in Deed Book 496 at page 129 and to an agreement to widen the road with the county in Deed Book 944 at page 184.

There is a mortgage by Poinsett Service Corporation to Travelers Rest Federal Savings and Loan Association in the sum of \$25,000.00 dated April 3, 1972, recorded in Mortgage Book 1228 at page 353. These two mortgages shall be of equal rank. A default under either mortgage will constitute a default under both mortgages.
