- (1) That this mortgage shall secure the Mortgagee for such fur ther sums as may be extended hereitter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs by other purposes pursuant to the covenants herein. - (3) That it will keep all improvements now existing or hereafter erected in good repair, and, in the case of a construction lean, that it will continue construction until completion without interruption, and should it fall is do so, the Mortgages may, at list option, enter upon said premises, make whatever repairs are necessary, including the completion of any construction work underway, and charge the expenses for such repairs or the completion of such construction to the mortgage debt.

 (4) That it will pay, when due, all taxes, public assessments, and other governmental or municipal charges, fines or other impositions against the mortgaged premises. That it will comply with all governmental and municipal laws and regulations effecting the mortgaged premises.

 (7) That the Mortgagor shall hold and enjoy the premises above conveyed until there is a detault under this mortgage or in the note secured hereby, that then this mortgage shall be utterly null and void; otherwise to remain in full force and virtue.
- (8) That the covenants herein contained shall bind, and the benefits and advantages shall inure to, the respective heirs, executors, administrators, successors and assigns, of the parties hereto. Whenever visid, the singular shall included the plural, the plural the singular, and the use of any gender shall be applicable to all genders.
