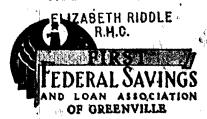

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of

ALL that piece, parcel or lot of land situate, lying and being on the southwestern side of Pinehurst Drive near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 25, Section B of a submitivision known as Pinehurst, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book S at Page 77 and according to said plat has the following metes and bounds, to-wit:
