- (1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the convenants herein. - (8) That the covenants herein contained shall bind, and the benefits and advantages shall innire to the respective heirs, executors, administrators, successors and assigns, of the parties hereto.
