"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Jones Avenue, known and designated as Lot 5 on a plat of the property of W. C. McDaniel which is recorded in the R. M. C. Office for Greenville County in Plat Book "F", at page 186, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Jones Avenue at the corner of lot 6 and running thence N. 1-0 E. 70 feet to an iron pin at the corner of lot 4; thence with the line of lot 4, S. 89-0 E. 190.2 feet; thence S. 1-01 E. 70.05 feet; thence N. 89-0 W. 192.7 feet to the point of beginning.
