

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, near Roper Mountain Church and having the following metes and bounds, to-wit:

BEGINNING at an iron pin near road, and running thence W. 232.32 feet (3.32 chains) to an iron pin near Roper Mountain Church; thence N. 22 1/2 W. along another road to a stone 436.92 feet (6.62 chains); thence S. 44 1/2 E. 567.6 feet (8/60 chains) to beginning corner, containing 1 1/4 acres, more or less; being the same conveyed to me by J. H. McIntyre by deed dated December 23, 1970 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 905 at Page 150."
