(10) To comply with all laws, ordinances; and regulations affecting the property.

(11) To pay or reimburse the Government for expenses reasonably necessary or incidental to the protection of the lies and priority. hereof and to the enforcement of or the compliance with the provisions hereof and of the note and any supplementary agreement (whether before or after default), including but not limited to costs of evidence of citie to and survey of the property, costs of recording this and other instruments, attorneys' fees, trustees' fees, court costs, and expenses of advertising, selling, and conveying the property.

(12) Neither the property nor any portion thereof or interest therein shall be leased, assigned, sold, transferred, or encumbered, voluntarily or otherwise, without the written consent of the Government. The Government shall have the sole and exclusive rights as mortgages hereunder, including but not limited to the power to great consents, partial releases, subordinations, and satisfaction, and no insured leader shall have any right, title or interest in or to the lieu or any benefits hereof.

(13) At all reasonable times the Government and its agents may inspect the property to excertain whether the covenants and agreements contained hereis or in any supplementary agreement are being performed.

(14) The Government may extend and defer the maturity of and renew and resmortize the debt evidenced by the note or any indebtedness to the Government secured hereby, release from liability to the Government any party so liable thereon, release portions of the property from and substitute the lies hereof, and waive any other rights becomen, without affection the lien or priority hereof or the liability to the Government of Borrower or any other party for payment of the note or indebtedness secured hereby except as specified by the Government la writing.

(15) If at any time it shall appear to the Government that Bornwer may be able to obtain a loan from a production credit association, a Federal land bank, or other responsible conserving or gives peakly some a state of the conserving or release and the conserving or release a a Federal land bank, or other responsible cooperative or private credit source, at reasonable rates and terms for loans for similar purposes and periods of time, Borrower will, upon the Government's request, apply for and accept such loan in sufficient amount to pay the note and any indebtedness secured hereby and to pay for any stock necessary to be purchased in a cooperative lending agency in connection with such loes.
