"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, lying and being on the westerly side of Selwyn Drive, and shown as Lot 4 on plat of Timberlake as recorded in the R. M. C. Office for Greenville County in Plat Book BB at Page 185 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Selwyn Drive at a point near intersection of Selwyn Drive and Hermitage Road, said pin being at the corner of Lot 4, and Lot 124 of Lake Forest, Section 3, on plat recorded in Plat Book GG at Pages 76 and 77, revised in Plat Book BB at Page 20, and running thence with the joint line of said lots, S. 68-21 W. 152 feet to an iron pin, joint rear corner of Lots 4 and 5 of Timberlake; thence along the joint line of said lots, S. 21-39 E. 180 feet to an iron pin on the northerly side of Selwyn Drive; thence around a curve of Selwyn Drive, the chord being N. 36-37 E. 105.7 feet to an iron pin on the westerly side of said Drive; thence continuing with the westerly side of said Drive, N. 4-53 E. 139 feet to the beginning corner;

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all ilens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
