

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as—lot No. 3 on revised plat of Staunton Heights subdivision made by Hugh J. Martin, R.L.S. April 16, 1971, recorded in the RMC Office for Greenville County in plat book 4 N page 38, and having according to said plat the following metes and bounds, courses and distances to-wit:

Beginning at an iron pin on the south side of Sunnyview Drive, the joint front corner of Lots Nos. 2 & 3 and running thence with the joint line of said lots S. 22-58 W. 175 feet to an iron pin; thence N. 67-02 W. 143 feet to an iron pin corner of Lot No. 4; thence N. 22-58 E. 175 feet to an iron pin on the south side of Sunnyview Drive; thence with the south side of said street S. 67-02 E. 143 feet to the beginning corner.
