"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate, lying and being on Old Spartanburg Road, and being shown on a Plat of Property of E. W. Peden, recorded in the R. M. C. Office for Greenville County, in Plat Book VVV, at Page 13, containing 13.81 acres, more or less, and having, according to said Plat, the following metes and bounds, to-wit:
