"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the Town of Fountain Jun, S. C., and being designated as Lot #29 on plate of H. L. Donahoo Surveror and made on the 9th and loth day of March, in the year 1953.
