"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being shown as LOT NO. 73 on the eastern side of Dagenham Drive, on a plat of section III of Wade Hampton Guardens, recorded in the R.M.C. Office for Greenville County in Plat Book YY at page 179.

This being that same property conveyed to mortgagors by deed of Walter B. Meadors dated March 19, 1969, and recorded in R.M.C. Office for Greenville County in Deed Book 864 at page 435.
