ALL that certain piece, parcel or lot of land, situate, lying and being in Greenville Township, Greenville County, State of South Carolina, containing 6.12 acres, more or less, according to a plat of J.E. Acuff property prepared by John C. Smith, R.L. S., on June 13, 1969, and having according thereto the following courses and distances, to-wit: BEGINNING at an iron pin in the center of Bent Bridge Road at the joint corner with other property of Joe E. Acuff, and running thence along said road, South 52-58 West 185.6 feet to a curve; thence South 20-33 West 42.2 feet to an iron pin; thence South 43-30 East 400 feet to an iron pin; thence South 56-48 East 939 feet to an iron pin; thence North 30-15 West 941.2 feet to an iron pin; thence along the read of the Acuff lot South 45-58 West 299.2 feet to an iron pin; thence along the western side of the Acuff lot North 30-30 West 410 feet to the point of BEGINNING.
