"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Town of Fountain Inn, and being more particularly described as Lot No. 8 as shown on a plat entitled "A subdivision of Woodside Mills, Fountain Inn, S. C.", made by Piedmont Engineering Service, Greenville, S. C., October, 1952, and recorded in the Office of the Register of Mesne Conveyance for Greenville County, S. C. in Plat Book BB at Rage 83. According to said plat, within described lot is also known as No. 1 Fourth Street and fronts thereon 69 feet.
