All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being in the State of South Carolina, County of Greenville, in the City of Green ville, on the Western side of Druid Street, being shown and designated as Lots No. 1, 8 and the Southern one-half of Lot 9, Block A, on a plat of STONE ESTATES made by C. M. Furman, Jr., Engineer, dated October, 1931, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book G, at page 292, and having, according to said plat, the following metes, and bounds, to-wit:
