WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Kiertgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the fufther sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

ALL that piece, parcel or lot of land, together with all buildings and improvements thereon, situate, lying and beingon the Western side of the Old Piedmont Highway (former U. S. Highway 29) in Gantt Township, Greenville County, South Carolina, being shown and designated as Lot No. 24 on a plat of E. A. Smythe, et al, made by Dalton & Neves Engineers dated November, 1935, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book D, at page 171, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of the Old Piedmont Highway at the joint front corners of Lots Nos. 23 and 24, and running thence along the Western side of said Highway N. 1-40 E. 150 feet to an iron pin at the corner of Lot 25; thence with the common line of Lots Nos. 24 and 25 N. 83-42 W. 569.3 feet to an iron pin on the right-of-way of the Southern Railway Company; thence along the right-of-way of the Southern Railway Company and following the curvature thereof, the chord of which is S. 9-35 W. 200.2 feet to an iron pin at the corner of Lot No. 23; thence along the common line of Lots Nos. 23 and 24 S. 88-34 E. 595 feet to an iron pin, the beginning corner.

The above described property is the same conveyed to the Mortgagors by deed of Mary W. Putman recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 950, at page 632, and by deed of William R. Gaston to be recorded herewith. The Mortgagors herein own and hold the above described property as partners d/b/a Dud-Lin Investments under written agreement dated April 24, 1972, and said property is held as a part of the assets of said partnership.

Together with all and stingular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or littled thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever

The Mortgagor covenants that it is lawfully soited of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagos further covenants and agrees as follows:

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage styll also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing

(2) That it will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and have attached theiroto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premiums therefor when due, and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the balance owing on the Mortgage debt, whether due or not.
