- 4. The lien of this instrument shall remain in full force and effect during any postponement or extension of the time of payment of the ladebtechness or any part thereps secured hereby.

He will pay all taxes, assessments, water rates, and other governmental or municipal charges, fines, or impositions, for which provision has not been made hereinbefore, and in default thereof the Mortgagor may pay the same; and will promptly deliver the official rescipts therefor to the Mortgagor. If the Mortgagor falls to make any payments provided for in this section or any other payments for taxes, assessments, or the like, the Mortgagor may pay the same, and all sums so paid shell been interest as the rate provided for in the principal indebtedness from the date of such advance and shall be secured by this mortgago.

Upon the request of the Morigages the Morigages shall execute and deliver a supplemental note or notes for the sum or sums advanced by the Morigages for the alteration, modernization, improvement, maintenance or repair of said premises, for taxes or assessments against the same and for any other purpose authorized hereunder. Said note or notes shall be secured hereby, on a parity with and as fully as if the advance evidenced thereby were included in the note first described above. Said such and so fully as if the advance evidences the rate provided for in the principal indebtedness and shall be payable in approximately equal monthly payments for such period as may be agreed upon by the creditor and debtor. Failing to agree on the maturity, the whole of the sum or sums so advanced shall be due and payable thirty (30) days after demand by the creditor.
