That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to of for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Beatrice: Street, being shown and designated as Lots 60 and 61, on Map 1 of Camilla Park, recorded in the RMC Office for Greenville County in Plat Book G at Page 225, and according to said plat is described as follows:

BEGINNING at an iron pin on Beatrice Street at corner of Lots 59 and 60, and running thence with the joint line of said Lots 8 67-56 W 195.2 feet to an iron pin on a 20 foot alley; thence with said alley, S 18-32 E 135.9 feet to an iron pin, corner of Lot 62; thence with the line of said Lot N 67-52 E 193.4 feet to an iron pin on Beatrice Street; thence with said Beatrice Street, N 17-50 W 136 feet to the point of beginning.
