NOW, KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and be fore the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted bar gained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the southern side of Newman Street, in the City of Greenville, being shown as Lot 53 on plat of MCDANIEL HEIGHTS, made by Dalton & Neves, in April, 1941, recorded in Plat Book L, page 47, and having the following dourses and distances:

BEGINNING at a stake on the southern side of Newman Street, 182 feet West from Austin Street, corner of Lot 52 and running thence with the line of said lot, S. 4-20 E. 170.5 feet to a stake; thence S. 85-50 W. 70 feet to a stake, corner of Lot 54; thence with line of said lot, N. 4-20 W. 170.5 feet to Newman Street; thence with southern side of Newman Street, N. 85-50 E. 70 feet to the beginning comer.
