NOW, KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Most gages at any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and be fore the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bar gained, sold and released, and by these presents these grant, bargain, sell and release unto the Mortgagor, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern aide of Brookwood Drive, being shown as Lots Nos. 5 and 6 of Blook "G" of Stone Estates, said plat being recorded in Plat Book G at Page 292 in the RMC Office of the Greenville County Courthouse and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Brookwood Drive, at joint front corner of Lots 4 and 5 of Block G and running thence with the line of Lot 4 S 78-38 E 150.5 feet to an iron pin; thence N 9-30 E 50 feet to an iron pin at rear corner of Lot 7; thence with the line of Lot 7 N 78-38 W 149.6 feet to an iron pin on Brookwood Brive; thence with the eastern side of Brookwood Drive S 11-22 W 50 feet to the point of beginning.
