WHEREAS the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. (hereinafter referred to as Mortgagee) in the sum of Twenty-five Thousand Five Hundred and no/100-----DOLLARS

of 25,500.00 as evidenced by the Mortgagor's note of even date bearing interest as stated in said note and payable as therein stated or as modified by mutual agreement in writing the final maturity of which is 29 years after the date hereof unless extended by mutual consent the terms of said note, and any agreement modifying it are incorporated herein by reference and

NOW KNOW ALL MEN That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township on the south side of Devenger Road and shown according to survey and plat by Webb Surveying & Mapping Company dated December, 1972 and having the following metes and bounds, to-wit:

BEGINNING at a stake on the south side of Devenger Road, which stake is 1,350 feet, more or less, east of Boiling Springs Road and running thence with Devenger Road N. 72-07 E. 292 feet to a stake; thence S. 41-46 E. 554.3 feet to a stake; thence S. 31-27 W. 251.4 feet to a stake; thence N. 47-19 W. 461 feet to a stake; thence N. 38-10 W. 286.5 feet to the beginning corner. The above tract is shown as Tract C on the above plat and contains 1.99 acres, more or less.

This is the same property conveyed to the mortgagor by deed of J. Henry Chapman to be recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
