"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina; County of Greenville, on the eastern side of McPherson Lane in the City of Greenville, being known and designated as Lot No. 33 of the T. A. Donaldson property prepared by Dalton & Neves, Engineers, dated April 1935, recorded in the RMC Office for Greenville County in Plat Book H at Page 284, and having, according to said plat, the following metes and bounds, to wit:
