(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-six Thousand Six Hundred and No/100

(\$ 26,600.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgage at any time for advances made to or for his acceptant by the Mortgage, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgage at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgage, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the westerly side of Starsdale Circle, near the City of Greenville, S. C., and being designated as Lot No. 5 on plat entitled "Starsdale Manor" as recorded in the RMC Office for Greenville County, S. C., in Plat Book NN, page 9 and having, according to said plat, the following metes and bounds, to-wit:

BECINNING at an iron pin on the westerly side of Starsdale Circle, joint front corner of Lots 5 and 6 and running thence along the common line of said lots 8 74-17 W 150.6 feet to an iron pin; thence 8 17-0 E 158.9 feet to an iron pin, joint rear corner of Lots 4 and 5; thence along the common line of said lots N 49-40 E 181.7 feet to an iron pin on the westerly side of Starsdale Circle; thence along said Circle N 28-06 W 85 feet to an iron pin, the point of beginning.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgager promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgager's amount and collect it as part of the debt secured by the mortgages

The mortgagors agree that after the expiration of ten years from the date hereof, the mortgagee may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this losm, and the mortgager agrees to pay to the mortgagee as premium for such insurance one half of 1% of the principal balance then existing.

Together with all and singular the rights, members, hereditaments; and appurtenances to the same belonging or in any way incident or appertaining, and all of the retus, issues and profits which may arise or be had therefrom and including all heating plumbing, and lighting fixtures and any other squipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual squashold furniture; he considered a part of the real grade.
