It is hereby agreed, that should any default be made in the payment of inferest on said first mortgage, and such interest remains unpaid and in arrears for ten days, or should any suit be commenced to foreclose said first mortgage, then the amount secured by this mortgage and the accompanying note shall become and be due and payable at any time thereafter at the option of the owner or holder of this mortgage.

do hereby bind our sel Ves and beirs, executors and administrators, to procure or execute any further necessary assurances of title to the said premises, the title to which is unencumbered, and also to warrant and forever defend all and singular the said Premises unto the said mortgagee Domestic Loans of Greenville, Inc.

and assigns, from and against heirs, executors and administrators

and all persons lawfully claiming, or to claim the same or any part thereof.

AND IT IS AGREED, by and between the parties hereto, that the said mortgagor administrators, shall keep the buildings creeted, or to be erected on said premises, insured against loss or damage by fire, for the benefit of the said mortgagee, for an amount not less than Two-thousand, sixteen and no/100 * * * * * * * Dollars. in such company as shall be approved by the said mortgagee, and shall deliver the policy to the said mortgagee, and in default thereof, the said mortgagee Domestic Loans of Greenville, Inc. effect such insurance and reimburse themselves under this mortgage for the expense thereof, with interest thereon, from the date of its payment.
