


That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oaklawn Township, containing 9.56 acres, more or less, Tract 1 on a plat of Property of Grover C. Clark and Mattie G. Clark, and being recorded in the R.M.C. Office for Greenville County in Plat Book DD at Page 17, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the center of a surface treated road at the corner of property of Mrs. R. A. Coker, thence N. 16-15 E. 710 feet along property now or formerly owned by Orwell Babb to an iron pin, thence N. 73-52 E. 800 feet to an iron pin, thence S. 33-50 W. 1185 feet to a point in the center of said road, thence with the center line of said road N. 73-40 W. 110 feet to a point, thence continuing with the center of said road N. 77-25 W. 200 feet to an iron pin at the point of beginning.
