TO ALL WHOM THESE PRESENTS MAY CONCERN:  
ROBERT E. BUCK III AND CHARLES N. BUCK

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **TWELVE THOUSAND FIVE HUNDRED AND NO/100THS-----** DOLLARS (\$ 12,500.00 ), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown as Lot No. 153 on plat of FRESH MEADOW FARMS recorded in the R. M. C. Office for Greenville County in Plat Book NN, at page 85, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Miracle Drive at the corner of Lot No. 134, and running thence S 1-30 E 100 feet to an iron pin; thence S 60-07 W 85.5 feet to an iron pin; thence N 1-30 W 143.3 feet to an iron pin on the southern side of Miracle Drive; thence with said Drive, DUE EAST 75 feet to the point of beginning and being the same conveyed to us by L. A. Moseley and C. Henry Branyon by deed to be recorded of even date herewith.
