"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon situate, lying and being in the State of South Carolina, County of Greenville,

Unit No. 4-B in Briarcreek Condominiums, Horizontal Projecty Regime, situate on or near the Southerly side of Pelnam Hoad in the City of Greenville, County of Greenville, State of South Carolina, as more particularly described in Master Leed and Declaration of Condominium, dated September 1, 1771, and recorded in the R.M.C. Office for Greenville County, Frank Carolina, in Deed Book 1871 at page 11.
