That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, bying and being in the State of South Carolina, County of Greenville, situate on the northeastern side of E. Faris Road Extension, and being composed of Lot No. 81 and a part of lot No. 80 of Forest Heights Subdivision as shown on a plat thereof recorded in the RMC Office for Greenville County in Plat Book P at page 71, and also shown on the city block book at 98-2-16 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots No. 81 and 82, and running thence along the joint lines of said Lot N. 67-20 E. 151.2 feet to an iron pin; running thence S. 47-44 E. 90.1 feet to an iron pin in line of Lot No. 80; running thence through lot No. 80 S. 52-54 W. 178.6 feet to an iron pin on E.
