TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, WE, W.D. OWENS & VERTIE G. OWENS

(hereinafter referred to as Mortgagor) is well and truly indebted unto Fulton H. Anthony

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

-----Six Thousand & No/100-----Dollars (\$ 6000.00 ) due and payable in monthly consecutive payments of \$72.80 including principal & interest for a term of 10 years until paid in full.

with interest thereon from date at the rate of 8 per centum per annum, to be paid:

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Paris Mountain Township, adjoining lands formerly owned by R. L. Greene and the heirs of Perry Batson and being described as follows:

BEGINNING at a stone at the southwest corner and running thence N 27-3/4 W. 4.95 chains to iron pin on road above Perry Batson's homeplace; thence N 61 E. 6.05 chains to iron pin; thence S 27-3/4 E 4.95 chains to iron pin; thence S 61 W 6.08 chains to the beginning corner; containing three (3) acres, more or less, and being shown as Lot 1, Block 2, Page 482 of the County Block Book.

This being the same property conveyed to C. N. Morgan and Lillie C. Morgan by Deed recorded in the RMC Office for Greenville County in Deed Book 727, at Page 203.

This is also that same piece of property conveyed to Fulton H. Anthony by Deed of C. N. Morgan and Lillie C. Morgan on May 4, 1965, and recorded in the RMC Office for Greenville County, State of South Carolina, in Book 772, Page 445. This being the same property conveyed of even date by the said Mortgagee to Mortgagor's. This being a purchase Money mortgage.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
