All that certain piece, parcel or lot of land situate, lying and being on the South side of Long Hill Street, in the City of Greenville, being known as lot 88 on plat of Augusta Road Hills, made by Dalton & Neves, December 1940 recorded in the RMO Office of Greenville County, S.C.

To have and to hold, with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, unto the Mortgagee, provided always, and this instrument is made, executed, sealed and delivered upon the express condition that if the said Mortgagors shall pay in full to the said Mortgagee the above-described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue. Upon default in making any payment of said Note when the payment becomes due, then the entire sum remaining unpaid on said Note shall be due and payable by the exercise of the option of acceleration above described, and this Mortgage may be foreclosed as provided by law for the purpose of satisfying and paying the entire indebtedness secured hereby.
