"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being known and designated as Lot 459 according to a plat of Del Norte Estates, Section V, said plat being dated June 19, 1972 and recorded in the RMC Office for Greenville County in Plat Book 4R at Page 17 and having, according to said plat, the following metes and bounds, to wit:
