KNOW ALL MEN' That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well-and truly paid by the Mortgage at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 98, Section F of Gower Estates, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book JJJ at Page 99, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northerly side of Henderson Road at the joint front corner of lots 97 and 98 and running thence with the common line of said lots, N. 11-16 E., 188.9 feet to an iron pin; thence S. 87-45 E., 156.7 feet to an iron pin; thence S. 9-27 W., 180 feet to an iron pin; thence S. 19-50 E., 35.5 feet to an iron pin on Henderson Road; thence with Henderson Road N. 78-14 W., 149.2 feet to an iron pin; thence continuing with said road, N. 82-48 W., 30 feet to the point of beginning.
