That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of GREENVILLE

State of South Carolina: ALL that piece, parcel or lot of land in the State of South Carolina, County of Greenville, being known and designated as Lot No. 227 on plat of Augusta Road Ranches and recorded in the RMC Office for Greenville County in Plat Book M, page 47 and a more recent plat entitled "Property of Willie Mae Wardlaw" prepared by Carolina Engineering and Surveying Co. dated February 17, 1973, and having, according to the more recent plat, the following metes and bounds, to-wit: BEGINNING AT an iron pin on the southern side of Gatlin Avenue at the joint front corner of Lots 226 and 227 and running thence along the edge of Gatlin Avenue, N. 89-47 E. 60 feet to an iron pin at joint front corner of Lots 228 and 227; thence S. 0-13 E. 140 feet to an iron pin at the joint rear corner of Lots 228 and 227; thence S. 89-47 W. 60 feet to an iron pin; thence N. 0-13 W. 140 feet to an iron pin on Gatlin Avenue, being the point of beginning.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:
