WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of S. C. Highway 20, containing 2.0 acres, more or less, being known and designated as the PROPERTY OF MAX W. KENNEDY AND GWEN KENNEDY on plat dated October, 1966, and prepared by Dalton & Neves, recorded in the R. M. C. Office for Greenville County, in Plat Book NNN at Page 67, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of S. C. Highway 20 at the joint corner of the premises herein described and property now or formerly of Ollie T. Chapman and running thence with the common line of said properties, N. 87-30 W. 500 feet to an iron pin; thence continuing with the common line of said properties, N. 2-30 E. 78.2 feet to an iron pin in the line of property now or formerly of Mrs. C. C. Good; thence with the line of property now or formerly of Mrs. C. C. Good, N. 71-30 E. 535.56 feet to an iron pin on the eastern side of S. C. Highway 20 at the joint front corner of the premises herein described and property now or formerly of Mrs. C. C. Good; thence with the eastern side of S. C. Highway 20, S. 2-30 W. 270.2 feet to the point of beginning.
