**MORTGAGE**

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Robert D. Henderson and Carole T. Henderson  
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Fourteen Thousand Two Hundred Fifty and No/100----- DOLLARS (\$ 14,250.00-----), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, being shown as Lot No. 16, Section 4, on plat entitled "Subdivision for Dunean Mills, Greenville, S.C.," recorded in the RMC Office for Greenville County, South Carolina, in Plat Book S, at Pages 173-177; and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at an iron pin approximately 140 feet from the intersection of Stevens Street and Hutchins Street, said iron pin being on the southern side of Stevens Street, and running thence, S. 13-14 W. 118.8 feet to an iron pin; thence, N. 71-39 W. 144.5 feet to an iron pin on the edge of Hutchins Street; thence running with said street, N. 12-34 E. 128.3 feet to a point; thence, S. 62-34 E. 12.3 feet to an iron pin on Stevens Street; thence with said street, S. 64-23 E. 138.7 feet to an iron pin, the point of beginning.
