"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Grannyilla, in the City of Grannyilla, during Greenville, in the City of Greenville, lying

on the northern side of East Washington Street and being known rand designated as Lot No. 93, Block E of East Park, a part of Boyce's Addition to Greenville as shown on plat recorded in the RMC Office for Greenville County, South Carolina, in Plat Book A, at Page 383, and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at an iron pin on the northern side of East Washington Street, joint corner with Lot No. 92 (this being 450 feet from the intersection of Ebaugh Avenue) and with lines of Lot No. 92 running, N. 17-30 W. 154 feet to an iron pin on a ten-foot alley; thence with said alley, S. 72-30 W. 50 feet to an iron pin, joint corner with Lot No. 94; thence along the line of Lot No. 94, S. 17-30 E. 142 1/2 feet to an iron pin on East Washington Street; thence with said road, N. 86-30 E. 50 feet to an iron pin, the point of beginning.
