All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the intersection of Golden. Grove Lane and Golden Grove Circle, being known and designated as Lot No. 31 as shown on plat entitled "GOLDEN GROVE ESTATES", Section 1, dated September 7, 1971, prepared by R. D.
