To All Whom These Presents May Concern:

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Two Hundred Forty-

seven and 29/100ths -----(\$ 247.29) Dollars each on the first day of each mouth hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being located on the southeastern side of Del Norte Road near the City of Greenville, and being known and designated as Lot No. 193 on plat entitled "Del Norte Estates, Section II", recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 4N at pages 12 and 13, and having according to said plat the following metes and bounds. to-wit:

BEGINNING at an iron pin on the southeastern side of Del Norte Road at the joint front corner of Lots Nos. 192 and 193 and running thence along the southeastern side of Del Norte Road N. 43-30 E. 75.9 feet to an iron pin at the southerly corner of the intersection of said road and Del Norte Lane; thence around said intersection on a curve the chord of which is N. 82-54 E. 28.7 feet to an iron pin on the southwestern side of said Lane; thence along said Lane S. 57-44 E. 107.6 feet to an iron pin at the joint front corners of Lots Nos. 193 and 194; thence S. 43-30 W. 126.75 feet to an iron pin at the joint rear corner of Lots Nos. 192 and 193; thence along the common line of said lots N. 46-30 W. 120 feet to an iron pin at the point of beginning.
