ALL that piece, parcel or lot of land situate, lying and being on the southern corner of the intersection of Hudson Road and Continental Drive near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 103 of a subdivision known as Merrifield Park, Section II, plat of which is recorded in the R.M.C.
