


That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 8

on plat entitled "Berea Forest Apartments" as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4Y, at Pg. 118, and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at an iron pin on the edge of Berea Forest Circle, joint front corner of Lots Nos. 8 and 7 and running thence with the common line of said lots, S. 32-51 W. 138.1 feet to an iron pin; thence, N. 55-14 W. 5 feet to an iron pin; thence, N. 50-06 W. 80.4 feet to an iron pin; thence, N. 41-19 E. 135.2 feet to an iron pin on the edge of Berea Forest Circle; thence with said Circle, S. 52-11 E. 64 feet to an iron pin, the point of beginning.
