NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid cabb, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$2.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, Chick Springs Township, being a portion of those certain lots known and designated as Lots 19 and 20 on a plat of the property of Paris-Piney Park, which plat is recorded in the Office of the RMC for Greenville County in Plat Book H at Pages 19 and 20, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Piney Mountain Road which pin is 244.8 feet more or less from the intersection of Paris Mountain Road and Piney Mountain Road, the joint corner of Lots 18 and 19 and running thence with the joint line of said Lots S. 34-30 w. 107.5 feet to a point; thence through Lots 19 and 20 S. 55-30 E. 75 feet to an iron pin; thence through the center of Lot 20 N. 34-3 E. 107.5 feet to an iron pin on the Southern side of Piney Mountain Road; thence with said Road N. 57-14 W. 75 feet to the point of Beginning.

Together with all and singular rights, members, herdstaments, and appurtuances to the same belonging in any way incident or appurtuaning, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting pertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgages, its heirs, successers and assigns, forever.

The Mertgager covenants that it is tawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mertgager further covenants to warrant and forever defend all and singular the said premises unto the Mertgages forever, from and against the Mertgages and all persons whomsoever lawfully claiming the same or any part thereof.
