C., (hereinafter referred to as Mortgageo) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of TWENTY-FIVE THOUSAND AND NO/ 100THS-

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being shown and designated as Lot No. 37 on plat entitled "Pinehurst Section II", dated May 11, 1960, prepared by J. Mack Richardson, R.L.S., recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book MM at page 153, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Vista Drive, joint front corner of Lots Nos. 36 and 37, and running thence with the line of Lot No. 36, S. 31-35 W. 84.1 feet to an iron pin at the joint corner of Lots Nos. 37, 36 and 38; thence with the line of Lot No. 38, S. 63-27 W. 170.4 feet to an iron pin on the Eastern side of Linden Drive; thence along the Eastern side of Linden Drive, which line is curved, the chord of which is N. 12-55 W. 60 feet to an iron pin; thence continuing with the Eastern side of Linden Drive, N. 11-35 E. 51.9 feet to an iron pin; thence N. 22-40 E. 113.2 feet to an iron pin; thence with the curve at the Southern corner of the intersection of Linden Drive and Vista Drive, the chord of which is N. 74-35 E. 49.3 feet to an iron pin on the Southwestern side of Vista Drive; thence with the Southwestern side of Vista Drive, S. 53-30 E. 136.2 feet to an iron pin at the point of beginning.
