

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Town of Simpsonville, on the eastern side of Delmar Drive being shown and designated as Lot No. 45 on a plat of Brentwood, Section 2, made by Piedmont Engineers and Architects, Surveyors, dated May 19, 1972 recorded in the RMC Office for Greenville County, South Carolina in Plat Book 4-R, page 5 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on the eastern side of Delmar Drive, the joint front corner of Lots Nos. 45 and 46 running thence with the joint line of said lots 45 and 46, N. 54-00 E. 154.0 feet to a point in the joint rear corner of Lots Nos. 45 and 46; thence with the line of property of Brentwood Subdivision, Section 1, N. 36-00 W. 110.0 feet to a point, the joint rear corner of Lots Nos. 44 and 45; thence with the joint line of Lots Nos. 44 and 45, S. 54-00 W. 154.0 feet to a point on the eastern side of Delmar Drive; thence with the eastern side of Delmar Drive, S. 36-00 E. 110.0 feet to a point, the point of beginning.
