Harold Hammett; running thence with the line of said property, S. 34-58 W. 634.7 feet to an iron pin; thence continuing with the line of said W. Harold Hammett, S. 23-12 W. 817.3 feet to an iron pin at the corner of property of George Henson, Jr.; running thence with the line of said property, S. 53-26 W. 283 feet to an iron pin in the line of property of Anne T. Green; and running thence N. 39-49 E. 420.1 feet to an iron pin; running thence S. 40-57 E. 209.95 feet to an iron pin; running thence S. 39-52 W. 420.7 feet to an iron pin in the center of Hammett Road; running thence with the center of Hammett Road, N. 40-47 W. 209.7 feet to the point of beginning.
